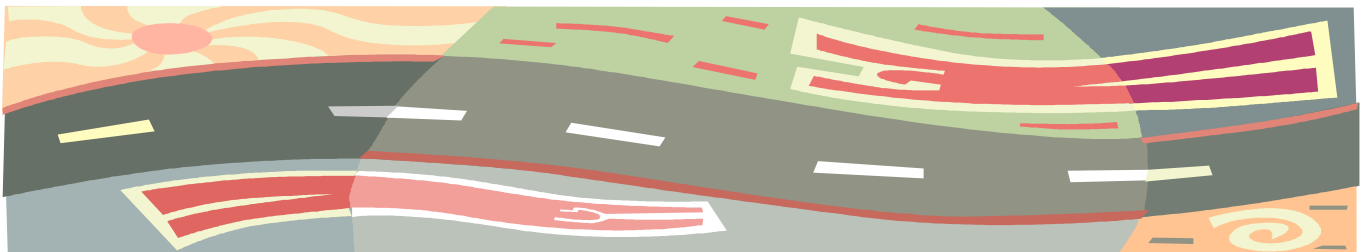

### ***Richard "Dick" Antone***

Formerly of Santa Rosa, California. Died 10-19-2012 of age related causes. He was 93.

He will be buried at Ocean View Cemetery Sunset Memorial Park, Eureka California. Arrangements by Majors Family Funeral Home, Springfield, Oregon. A graveside ceremony with family and friends.

He was born July 25, 1919 at Stewarts Point Rancheria, California to David and Stella Pinola Antone. He was a tribal member of the Kashia Band of Pomo Indians, Stewarts Point, California.

He married Karuk Tribal member Germaine George on April 18, 1946. She died June 4, 2004.

He was a private in the US Army during World War II. Richard performed duties in the European Theater of Operations in France, Luxembourg, Germany and England. His decorations were the Asiatic Pacific Campaign Medal, European African Middle Eastern Medal with Bronze Arrowhead World War II Victory Medal. Richard served in Normandy and France.

He worked as a farm hand, retired from the logging industry at Warm Springs Forest Products, Warm Springs, Or.

He enjoyed reading his bible, singing and playing the guitar, gardening, hunting, fishing, camping and visits with family and friends. He will always be remembered for his smile, he would go up and talk to anyone and enjoyed his conversations.

Survivors include two sons: John Antone of Orland Ca., Russell Antone of Gilroy, Ca. Five daughters: Myrtle Markgraf of Eugene, Or., Emilene Patrick and Starlite Antone of Madras, Or., Ardith Sanchez and Gloria Antone Rehder of Orland, Ca.; 27 grandchildren, 52 great-grandchildren and 7 great, great grandchildren.

He was preceded in death by one brother; Melvin "Lope" and five sisters; Maggie Frank, Daisy Smith, Effie Ramirez, Bertha Frank and Fay Pinola.

The family is forever grateful for the love, prayers and visits that our Dad received in his last years of his life, he was reunited with many family members of siblings who have gone on before him. ## The Kashaya Pomo Cultural Landscape Project by Kathy Dowdall, Caltrans Heritage Manager



### Where This Project Came From

I am trained as an archaeologist, ethnographer, and historian and have been working, volunteering, and collaborating with Kashaya tribal members since 1987. For the past 22 years, I have been working for Caltrans as a cultural heritage manager. My job is to make sure that all types of heritage places are protected along Caltrans highways in the nine Bay Area counties. Highway 1 in Kashaya territory is the most culturally sensitive stretch of highway with over 60 known heritage places. Some examples of Kashaya heritage places are fishing, hunting, and gathering areas that have been used in the past or are now used; ancestral villages and camps; places that need respect; and quarries and trails. In order to protect Kashaya heritage places and document information about them for future Kashaya generations, some tribal members and I spent about 15 years as volunteers collaboratively recording information. In 2005 I applied for federal funding to continue this work with more members of the Tribe. The Tribal Chair at the time, Eric Wilder, approved a partnership among the Kashaya Pomo Tribe, Caltrans, and State Parks. Once we got the funding, the project was approved to go forward by the Tribal Council in January of 2012. A Memorandum of Understanding to start work was reviewed by the Tribal attorney, and signed by Tribal Chair Emilio Valencia in May. We have until May of 2014 to finish the project.



### Project Goals

- ◆ A collaborative heritage management plan for Kashaya heritage places along Highway 1.
- ◆ Plans for turning sections of Highway 1 into a corridor that focuses on Kashaya heritage
- ◆ Plans for a walking trail in Salt Point State Park focusing on Kashaya heritage.

***Collaborative Heritage Management Plan:*** A collaborative heritage management plan improves our ability to protect Kashaya heritage places because it includes what the Tribe thinks is important about each place. One of the goals of this plan is to restore, bit by bit, as many heritage places as we can. So far this year, through collaborative heritage management, the Tribe and Caltrans were able to restore a small piece of the ancestral Mé-ti? ni Village. At the request of the Tribal Chair and Tribal Historic Preservation Officer, Caltrans removed a turn-out at the ancestral Mé-ti? ni Village, blocked it from any future public parking, and replanted it with native grasses.

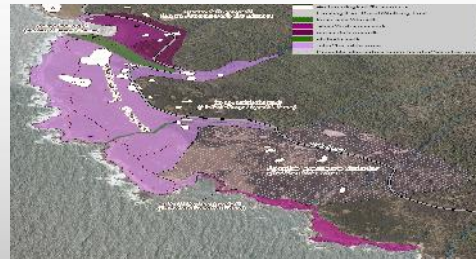
***Sections of Highway 1 as a Kashaya Heritage Corridor:*** Another part of the project includes plans for turning parts of Highway 1 into a heritage corridor that teaches the travelling public what the Kashaya community wishes to share.

### **Tribal Members Who Have Contributed So Far**

Through oral history interviews and family history research, contributors to this project so far include members of the Antone, Marrufo, Pinola, Parrish, and Wilder families.

### **A Heritage Questionnaire Is Coming in the Mail**

We would like to hear from all Tribal Members over the age of 15. We, the Tribal Chair, Tribal Historic Preservation Officer, two family focus groups, and I developed a heritage questionnaire that will be mailed out in November. The questionnaire is an important way for us to identify the links between the Kashaya community and Kashaya heritage places. The questionnaire is strictly anonymous and all members of the Tribe over the age of 15 are being asked to respond to it. There are about 15 questions and it doesn't matter how many of the questions you answer. If you can't answer a particular question, or don't want to, just go to the next one. Besides the mailer, copies of the questionnaire will be available in the Tribal Office and can be filled out there starting November 19th. Thank you in advance for taking the time to help us protect Kashaya heritage places.

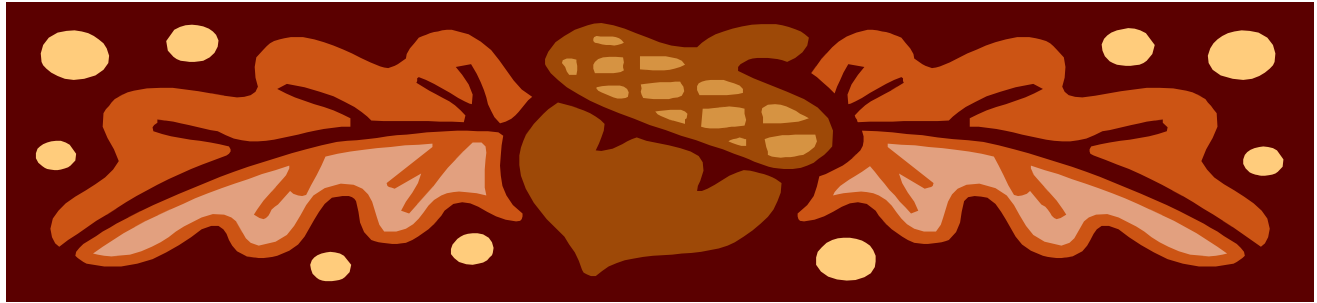
### **Would You Like to be Interviewed?**
